The following was noted:

- Bleach disinfectant will be used to wipe down all general surfaces.
- Hand wash sinks in the children and staff washrooms are available for hand washing prior to any food handling.
- Staff have acquired their food safety training.
- There is no designated refrigerator onsite, so there will be no perishable foods stored at the program.
- Utensils, cups, and plates are stored in a designated cupboard.
- All used utensils, cups, and plates will be taken away by Fueling Minds and cleaned and sanitized at their facility, then brought back to the program.
- Designated table set up for the placement of the food once delivered and staff will be serving the children (if the food is not pre-portioned out).
- There is a hot holding unit/warmer for any hot foods delivered from Fueling minds.
- It is recommended that a thermometer is purchased to measure the temperature of any hot foods that are delivered to the program. It is also recommended that a temperature log be kept for any hot foods.
